

Executive Director's Foreword



Our new strategy is driven by a simple idea: Collaboration. Over the past year, our partners have shared their insights with us. We've heard loud and clear their concerns about the climate crisis and the health of the environment. We've also heard about the pressure points and extraordinary work going on in public sector organisations working behind the scenes to drive the transition to net zero.

We're excited to announce our new strategy. It starts with our vision: A thriving Northern Ireland that lives in balance with nature, where communities prosper and future generations can flourish. Our strategy reaffirms our commitment to promote and enable the adoption of sustainable principles by individuals and organisations and in doing so, build a more sustainable future for Northern Ireland. As we step forward, we're building on what we've learned over the last 25 years and we'll retain the local convening and coordinating approach we know is so highly valued. But we want to make a bigger impact. Bolder change demands deeper partnership working. We don't expect to have all the answers but by working with others, together we'll be more than the sum of our parts.

Our strategy is built around four central pillars of work.

Inform

First, we're doubling down on our efforts to build capacity in the people and organisations at the forefront of the green transition. We'll develop and improve our communication and training offering, to educate and empower others to contribute to a cleaner, greener way of living and working.

Reform

Second, we know policy reform is critical to tackling some of the biggest environmental challenges we face. We'll engage policy-makers and hold them to account on their climate and sustainability commitments, through the All-Party Group that we facilitate and by engaging with government consultations.

Transform

Third, we'll simplify the way that organisations deliver sustainability, assisting with strategy development, and encouraging them to focus on simple, practical and effective actions.

Grow

Fourth, we know we need to make a bigger impact and to do that, we need to grow. We need to increase our resources, our capabilities and our reach. We'll be selective in where we draw our funding from so that we retain our independence whilst offering maximum flexibility to develop our services where they are most needed.

We believe Northern Ireland has a massive opportunity – we have the natural resources, the technology and the talent to make us an exemplar in the race to net zero. Our modest scale is an advantage – enabling us to move fast. Our abundance of wind and geothermal energy, combined with ground-breaking local technology, can provide sustainable, reliable, and affordable green energy, and remove our reliance on imported fossil fuels.

Northern Ireland is unique in that single institutions hold majority control over electricity, gas, water, and public transport. This means that, in theory at least, we can be swift and efficient, making sweeping changes at scale. That theory is already becoming a reality, with Translink on schedule to decarbonise its bus fleet by 2040. NI Water is also leveraging its assets

to deliver green energy solutions, and the Housing Executive is retrofitting 300 of its houses with energy efficiency measures, low carbon heating, renewable power, and storage with improved householder awareness. Local Authorities are also taking action, publishing ambitious targets and plans to act on climate change. And with a Public Body Reporting Duty now in place, the rest of the public sector will surely follow suit. By harnessing public assets, and public procurement, the sector is ideally placed to drive the green transition.

Our 2030 strategy focuses on supporting Northern Ireland's net zero efforts, building on our existing work with the public sector to make an even greater difference in the years ahead. We want to support other sectors too, bringing the passion, purpose and expertise of our people to accelerate our shared goal to protect our environment and its resources, strengthen society, and improve lives. Let's make our green region the envy of all, paving the way to a brighter, cleaner, more prosperous future. The journey starts now and it starts with collaboration.

Our purpose


Meeting our needs, without compromising the planet

Sustainable NI is an independent charity dedicated to promoting and supporting sustainability in Northern Ireland. Our mission is: Inspiring and supporting action for a sustainable Northern Ireland where people, nature and the economy thrive together.

We work with councils, government, and businesses to influence policy, deliver projects, and inspire change through education, advocacy, and practical solutions.

We are founded on collaboration, sharing our knowledge and expertise. However our goal is not change; it is transformation.

Vision: A sustainable Northern Ireland

The challenge

We are living in a global climate, biodiversity and health emergency; the emergent features of unsustainable economic systems that urgently need reform. Northern Ireland has been slow to act on climate change due to political instability and the stop-start nature of government. Despite this, a Climate Change Act was introduced in 2022 committing the Northern Ireland Executive to Net Zero by 2050 and, for the first time, placing duties on public bodies to act and report on climate

change. This has renewed momentum on sustainability within Northern Ireland, with a Green Growth Strategy, Energy Strategy and Circular Economy Strategy now in place to drive the decarbonisation of our economy. These strategies and action plans, alongside insights from our clients, have formed the basis of our strategy up to 2030, guiding our work and focussing our efforts.



Insights

In 2023/24, Sustainable NI carried out a Needs Analysis Workshop involving 11 key public sector organisations in Northern Ireland to gather insights about what the public sector needs help with to tackle climate change and drive progress on sustainability.

Key insights are that public bodies require:

- 1. Clear and consistent leadership and policy A clear vision, strategy and delivery plan, aligned with national targets, providing clear duties to follow
- **2. Consistent methodologies -** Improved access to guidance, tools and improvement frameworks to deliver Net Zero
- **3. Increased capacity through skills development -** More support to change the culture of their organisations, through staff training and capacity building.

- **4. Relevant, up-to-date information and best practice** Signposting to information and support, including peer-to-peer support, and exchange of knowledge and best practice with others in a similar position.
- **5. Funding for coordinated and targeted projects and programmes** Scaled up finance and investment for climate action in their area as well as facilitated collaboration on climate projects and programmes to improve efficiencies of scale across the region.
- **6. Support to improve monitoring, reporting and verification -** Consistent reporting methods and standards for more effective decision-making.

These six insights have informed our strategy, making it client-led and client-focused.

We understand the power of education and information in driving improvement. That's why we'll offer training, tools, resources and forums, to support individuals and organisations in embedding sustainability into everyday practices - turning aspirations into reality. Sustainability education teaches people to think about the long-term impact of their actions on the planet and to make choices that help protect it for future generations. Through tailored communications, engaging training courses, and interactive forums, we'll strive to inspire individuals and organisations to adopt eco-conscious habits and contribute to a cleaner. greener way of living and working.

- inspire people to act on climate breakdown by sharing solutions and best practice
- inform organisations about key policy developments
- improve the knowledge and skills of those delivering the green transition through training and development opportunities
- enable collaboration and peer-to-peer learning through regular meetings




We'll transform how organisations deliver sustainability

We **inform** and empower individuals and organisations to embrace sustainable practices by providing engaging communications and training.


We **reform** policy by championing sustainability principles in new and existing policy frameworks.

Our 2030 ambition

The ambition through this strategy is to unite key public, private and community sector stakeholders, delivering expert support to accelerate the adoption of sustainable practices, and applying a social lens to ensure the transition to net-zero is fair.

But we want to make a bigger difference in the next five years. Our goal for 2030 is for Sustainable NI to become a recognised catalyst of sustainable progress in Northern Ireland and the partner of choice for for climate and sustainability support.

To deliver greater impact, we will:

- grow our capacity by increasing funding by 50% on current levels and working towards a more diverse funding mix, broadly in thirds (see p.19)
- increase our capability by increasing training undertaken by staff and board members by 100% on current levels
- extend our influence by promoting our services to new audiences, including the general public, increasing our reach by 100%


Funding and Governance

Funding

Sustainable NI operates a hybrid funding model. This includes 'core' funding from councils and public bodies through subscriptions for support. This core funding enables Sustainable NI to have stability and to provide a base level of support to the public sector. Sustainable NI also receives other sources of funding from commercial contract work (services) and projects (grants). These funding sources will vary over time however we aim to have a more diverse funding mix in place, broadly in thirds, by 2030.

Governance

Sustainable NI is an independent, non-profit organisation, registered as a charity (Charity No NIC103426) and a company limited by guarantee in Northern Ireland (Company No NI038784). Our Board of Directors comprises representatives from the public, private, voluntary and community sectors who scrutinise our finances, risks, strategy and operations. The Board also ensure legal compliance. We publish our accounts and a report outlining the work we've carried out each year, to ensure full transparency.







Sustainable NI was formed in 1998 to promote and enable the adoption of sustainability principles by local authorities and other agencies of government and in doing so, build a more sustainable future for Northern Ireland.
