Terms of Reference	<p>Purpose - the Group will provide a forum for discussion between politicians, NGOs, business leaders and academics, to drive progress on climate action and sustainable development in Northern Ireland.</p> <p>Mission - to influence policymaking and put climate action and sustainability at the centre of political decision making in Northern Ireland.</p> <p>Function - to consider the potential implications of climate change for Northern Ireland and make recommendations to government on interventions to help Northern Ireland transition to a low-carbon, climate resilient economy.</p> <p>Specific functions include:</p> <p>Democratic Scrutiny: of central and local government input on climate action and sustainable development, and to influence regional policy approaches on these and related issues.</p> <p>Monitoring: the progress of central and local government on climate change and sustainable development approaches, including the role of arms-length bodies.</p> <p>Oversight: of coordination between local and central government and their partners on delivery of key climate and sustainability issues impacting on citizens, and over which councils and government can influence.</p> <p>Awareness: to ensure a shared understanding of key climate and sustainability issues and opportunities across all political parties, through the provision of independent information and best practice.</p> <p>Lobbying: for improvements in policy and for resources to deliver this agenda.</p> <p><u>Membership</u> Membership of the Group will be cross party and include representatives from the NI Assembly (at least 10 MLAs and parties from all three designations) as well as elected members from local councils.</p> <p><u>Frequency of meetings</u> The All Party Group will meet monthly, usually on the last Friday of the month, with an Annual General Meeting once per year. The meetings are usually virtual, with the occasional meeting being held in person at Stormont.</p> <p><u>External Groups</u></p>	

	<p>The Group will have a working relationship with other related All Party Groups, relevant boards, relevant council and departmental working groups and representative bodies, as well as energy and environmental organisations in the region.</p> <p>All members of the group will have speaking rights.</p> <p>Public observers may attend.</p> <p><u>Financial & Resource Implications</u> There will be some ongoing support costs in relation to the Group, which will be covered through existing public body subscriptions to Sustainable Northern Ireland.</p>
